Councillors will meet with Meachen and Bevan for a photograph and to thank them in person for their donation to make this project a success. Further training dates will be researched by Clerk.

### Spring Bulb Planting Project – update on progress and set date for planting.

A resident offered a donation of £100 towards the project. Councillors RESOLVED to accept and use to purchase Crocus and Daffodils.

All residents who responded to consultation were update on the project by email Councillors RESOLVED to have a site visit, in early September, with residents to create and confirm the planting plan.

Clerk to gain a proforma invoice from bulb company, order will increase due to donation: approx. 1,500 Crocus, 1, 2000 Daffodils with a delivery date mid-September, in order planting can take place soon after delivery.

Taylormade approached but no response in time for meeting.

### Litter Collection— A522 Beamhurst – update from East Staffordshire Borough Council (ESBC)

The Parish Council made enquiries with East Staffordshire Borough Council (ESBC) to ask if Beamhurst (A522) could be included onto the litter picking rota by their teams.

**ESBC advised the following (27.05.2021)**: "Many thanks to the residents that carry out their own litter pick, it Is greatly appreciated by ESBC. I have spoken to the crew that service the area in Beamhurst and determined that they litter pick that road once a month on the stretches where they are able to safely. However, I have asked that they monitor the road more often and litter pick accordingly". This information was posted on the website in the News Area. Councillors asked for a Thank You to be minuted for ESBC efforts with the request.

### Litter Bin in Beamhurst – update on installation.

East Staffordshire Borough Council (ESBC) have agreed to install a litter bin in Beamhurst,



located by the Parish Council noticeboard and Royal Mail post box (A522)— no date for installation given, as ESBC awaiting new bin stock to arrive.

LONELINESS IN COMMUNITY – consider research findings, discuss and approve Cllr Jones and Cllr Hemingway updated meeting with regards to the Nextdoor.co.uk neighbour app and will continue to research. Denstone Parish Council have a Sub Committee working on Loneliness solutions and Cllr Jones and Hemingway will approach to see if they can work with Denstone PC.

NALC document on Loneliness discussed and guidance points will be considered due to sensitivity of subject.

Several local initiatives for socialising were discussed and Councillors RESOLVED to create a list for residents and include on Parish Council website. Details to be provided to Clerk. Councillors agreed that the Parish Council could become a signposting hub and to continue to collect information that would be useful to residents. Parish Magazine to be notified.

**CROXDEN VILLAGE ENTRY SIGN**— consider update and approve location and budget Staffordshire County Council confirmed the most suitable location for a sign would be on the right-hand side approx. 15 metres from the junction with Hollington Road.

Cllr Atkins has confirmed a contribution to the cost of the project. Installation will take place in due course.

# SPEED LIMIT REDUCTION – HOLLINGTON ROAD, CROXDEN – discuss and approve action required.

JCB provide a letter of support to Croxden Parish Council by writing to Cllr White and Cllr Atkins (SCC) with regards to Parish Council request for the Speed Limit to be reduced from 60mph to 30mph, in order that Speed Watch Teams can operate on the road – 07.06.2021 Councillors RESOLVED for a letter to be drafted to Staffordshire County Council, outlining the support from JCB and requesting further consideration to reduce the speed limit.

21.07.008 **BEAMHURST – SPEEDING TRAFFIC A522** – discuss residents request and approve action needed

Councillors discussed several requests from residents to investigate the speeding traffic along A522. Councillors confirmed a notice for the website, advising residents to report any speeding issues to Staffordshire County Council (SCC) and Staffordshire Safer Roads Partnership. Councillors advised by residents that Cllr Atkins has requested a speed/traffic count for the road and Clerk will request data from the traffic count from SCC, which will be discussed at a future meeting. Councillors requested a minute to Thank the residents for their proactive approach to the situation.
