APM 23.05.0014 CONSIDER AND APPROVE REPAIRS TO CROXDEN 36 FOOTPATH

Cllr Hemingway advised Council that stile collapsed. It appeared to be a health and safety issue, so replacement stile was installed by WH Durose, using the Lengthsman Budget. The Council was informed, after the stile was repaired, by the Rights of Way Team that this area is a bridleway of 292m, so a bridle gate needs to be installed either to replace stile or alongside stile. Right of Way team apologised for the information error. Clerk will ensure that bridal way data is checked on the ORS in future. The landowner was approached about installation of a bridleway gate and refused permission due to the need to remove a mature tree.

The Parish Council noted that this bridle way links to Uttoxeter Rural Footpath 55. Councillor discussed the request from URPC to share cost of installing stile at Croxden 36/Uttoxeter Rural 55 junction and RESOLVED that stile is within URPC Parish and cannot offer help with cost.

Broadband – Croxden hamlet – update

Chairman updated the meeting, with the following: As you will be aware the Parish Council have been campaigning for better broadband in the parish for a few years now. We are therefore pleased to note that Openreach have now confirmed that full fibre (speeds up to 1G) broadband is now available to properties in Croxden. Lots of providers use Openreach (including Talk-Talk, Sky, BT, EE and many more) so



residents can choose a supplier to provide the Broadband service. The Council will continue to push for universal coverage in the whole parish.

Councillors discussed Beamhurst and Greatgate and RESOLVED to write to the DCMS Representative for an update. Lord Benyon responded to the Parish Council request for support with Broadband coverage. Council noted the response (see correspondence).

Beamhurst – Speed Indicator Signs (SID)

Following on from SCC confirmation that a SID would not be possible due to the speed limit of 50mph in Beamhurst. Cllr Bean wrote to Cllr Atkins at SCC (27.03.2023) the following: Currently the position in respect of speed limits is inconsistent along the length of the road from Uttoxeter to Tean. The section in question in Beamhurst has seen significant business and domestic development since 2021 and is the only section remaining at 50mph. We don't believe that adding additional white lines will make any significant difference to the speed or volume of traffic using the road and we believe it is significantly less cost effective than simply aligning the speed limits to the rest of the route (ie 40mph as per the Fole to lower Tean section).

The Parish Council would be happy to engage residents and local businesses directly on behalf of SCC to gather their views on the proposed scheme, (Scheme proposed: to use edge of carriageway markings in advance of and through the vehicle access points), if this would be of use to SCC and we could feedback the residents views back to SCC before any proposed work is carried out. The Parish Council is aware of a number of Beamhurst residents who would be happy to provide feedback.

The Council had not received a reply from Cllr Atkins by the meeting date and Clerk to follow up.

COMMUNITY WALK – Review event (15.04.2023) and confirm next Community Walk.



Community Walk took place on 15th April 2023.

Risk Assessment completed by Cllr Hall – 27.03.2027.

<u>Review of walk</u>: Councillors confirmed the event was a success, as combined a walk history talk and refreshments, all of which were well received.

<u>What went well</u>: Councillors feel it was well attended, new residents came along and the choice of things to do was a success.

Things to improve for next one: Councillors were of the view that the next event can be promoted via word of mouth and Facebook in both Croxden and Hollington. <u>Next walk date –</u> Tuesday 11TH July 2023 starting at Wood Farm, Greatgate. Time for Walk is 6.30pm – 7.30pm and will be led by ClIr Brandrick.

Beamhurst Hall Farm Uttoxeter Road Beamhurst Uttoxeter Staffordshire - Prior Approval for the conversion of two agricultural buildings to form 2 smaller dwellings and 2 larger dwellings (REVISED SCHEME): Comment from initial application resubmitted: The Council understands the buildings proposed to be



converted are modern steel framed barns, a case history suggests that these were not within the scope for permitted development and similar recent applications have been rejected on that basis. The Council has no particular objects apart from to highlight the above. Further comments submitted after March meeting: In addition to our previous comments, the Council would also like to raise concerns raised to us, by a resident, over the added development on an already busy road which could lead to further development and challenges to the sewerage and land drainage."

P/2023/00455 - The Old Vicarage Rocester Road Croxden Staffordshire ST14 5JQ -Erection of a covered external BBQ area with open swimming pool and alterations and increased height to an existing boundary wall – comments added 05.05.2023 We would wish highways to ensure that visibility is maintained when the wall is increased in size and consider whether the 30mph speed limit should be extended beyond this point from its current position which is closer to Hollington.

P/2023/00534 - Abbey View Farm Keelings Lane Croxden Staffordshire ST14 5JF - Change of use of annexe to holiday let. – Comments to be added:

We note that the application plans indicate two holiday units, One of these may be the existing residential property, but it would be useful to clarify this point. If there are two units, the indicated addition of 1 parking space seems insufficient to support the need. Finally we would also note that there seems to be a lack of notification to neighbours of these planning applications including site display in at least one place on or near the land to which the application relates

Warlow Bank, ST10 4HF – road signage for the corner and road dip was request by resident – reported again, PC made request in 2019 (Ref: 4150723) and were advised by SCC of the following: This is an update to your enquiry dated 01/03/2019 in relation to ALTON LANE. A highways inspector has now visited the site and added the following notes to the report: Our records do not show that the accident history at this location is significant to put in signage. The location would be difficult to put them in and the signage would be highly likely to be damaged during hedge cutting operations. The bend also does not appear to have enough severity to warrant the introduction of signage.

SCC confirmed the following on 15.05.2023:

We are currently working on a scheme with Alton Tower in respect of signage etc and where SatNavs are directing vehicles, we have raised your concerns with them and they agreed to fund signage for Sandy Lane. The engineer working on the current scheme has suggested providing a sign near the farm access with an incline warning sign. Councillors discussed the proposal and RESOLVED to request the following:

A sign showing bends for over a mile needed both by Wood Farm and at the other end of Alton Lane. Clerk to make request to SCC.

Broadband – Lord Benyon, Minister for Biosecurity, Marine and Rural Affairs, responded to the Parish Council request for support with rural broadband for the Parish on 05.04.2023 – "We recognise the importance of rural communities having



access to fast, reliable broadband, and it is good news that premises in your parish are currently in the scope of suppliers 'commercial plans. As you are aware, the identity of suppliers who have declared commercial build plans is commercially sensitive information and BDUK is unable to disclose it.

I am aware that BDUK's Local Delivery Lead for Staffordshire, has previously met your parish council and he would be happy to arrange another meeting to discuss the latest status of your community in relation to commercial build plans and Project Gigabit procurements. "

Broadband – two residents sent thank you emails to the Council for their efforts to bring broadband to Croxden Hamlet.

Mobile Phone signal – resident requested Council enquire about mobile phone signal in Croxden hamlet with providers.

Councillors to discuss the request and Cllr Bean provided the following information to residents':

Specifically on Mobile there is a project underway called Shared Rural Network. Details are <u>https://srn.org.uk/</u> This should improve things over time. Staffordshire County Council 2022 Community Fund – resident requested Council support for an application for insurance for a professional trishaw service, and some clothing etc for volunteers. Councillors RESOLVED for Clerk to investigate Parish Council Policy and respond to resident that Council cannot support.

Staffordshire County Council – New Chief Executive - Patrick (Pat) Flaherty has been appointed the new Chief Executive of Staffordshire County Council. John Henderson will step down and be replaced by Pat Flaherty in the summer 2023.

Alton Towers - Kate McBirnie, Head of Guest Excellence is being replaced by Deborah Harris, who will organise the next Parish Council Community Meeting at Oakamoor Village Hall, after the Election period is completed.

Community Engagement - NALC announces a new partnership with GoCollaborate, GoCollaborate is an innovative digital platform that is transforming how

communities work together. Councillors reviewed the website and RESOLVED that Croxden would not benefit from this service.
