\$137 The Department for Levelling Up, Housing and Communities has notified the National Association of Local Councils (NALC), that the appropriate sum for section 137(4)(a) of the Local Government Act 1972 (the 1972 Act) for local (parish and town) councils in England for 2024/25 is £10.81. The amount is a result of increasing the amount of £9.93 for 2023/24 by the percentage increase in the retail index between September 2022 and September 2023 under Schedule 12B to the 1972 Act.

Hollington Road, Rocester, Speed Limit - Freedom of Information - SCC schedule for proposed 40mph in Rocester – Clerk received a response from SCC giving information about the Rocester 40mph speed limit reduction. Chair requested a further submission and submitted the following to SCC: Croxden Parish Council would like a further Freedom of Information request in regards to the paragraph at the bottom of the "Statement of Reason" document that was provided. Croxden Parish Council would like to be provided with the total number of "local community" that made the request for the change of speed limit. Clerk received an update from SCC - Representations have been made previously by Croxden Parish Council regarding wishes for the Speed Limit to be reduced within the area of the parish, along Hollington Road. This has been considered in conjunction with the County Councillor for the area, Philip Atkins, under the Divisional Highways Programme. The matter was considered on the 7th September 2023. Using available data and information the application was declined. Although this application related to Hollington Lane in the area of Croxden, this area cannot be considered to be part of the FOI request in relation to Hollington Lane at JCB Golf Club. Public representations regarding speed at this location may be made via reporting system. Records have been examined on this system and no reports relating to speed have been found.

Council discussed the SCC response and RESOLVED to send a further Freedom of Information request.

Hollington Road, Croxden – Speed limit reduction – to be added onto May Agenda.

Appendix A

SPCA Motion (24.03.004)

"Croxden Parish Council has a number of roads within its rural parish that have a speed limit that are set by law at the National Speed Limit due to country roads automatically being set nationally at the National Speed Limit. Croxden Parish Council residents have for a number of years been asking for some of the roads within the parish to be reduced to 40mph from 60mph and the County Council unfortunately do not have the funds as such a request needs to go to the Secretary of State in Central Government.

Therefore, Croxden Parish Council would like SPCA to accept this motion and to work with NALC, in order that NALC can lobby the Government for a national change to be made to speed limits on rural roads. Rural roads are the most dangerous in the UK, accounting for nearly two thirds (60%) of all road deaths (RAC). With most country roads, even those with no central marking carrying the national speed limit of 60 mph there is a real temptation for motorists to drive at the limit because they are technically allowed to do so, even if it is inappropriate because of the driving conditions or local hazards.

Not only are too many lives are being lost on these roads, but damage is caused to roadsides and verges, pollution levels are increased and the speed of drivers acts as a major deterrent for other users of the system such as walkers, cyclists and horse riders. We believe the time has come where strategic, rather than tactical action needs to be taken.

The current position of requesting county councils to implement a change in speed limit has significant costs financially, plus in time and effort and generally is not progressed until death or serious injury has occurred.

We believe that this needs to change as a matter of urgency. Our suggestion would be to make a simple change to the national speed limit, reducing it to 40mph for carriageway roads without central line marking.

This approach has the following advantages: It could be implemented nationally with a simple administrative change by Government. A single national information campaign could be cost effectively run to communicate the benefits of the change to all road users no changes to signage would be required.

Croxden Parish Council would ask SPCA to consider the motion to request NALC to pursue this national change of speed limits with Central Government."
