# GREATGATE VILLAGE GREEN REGISTRATION – CONSIDER STAFFORDSHIRE COUNTY COUNCIL UPDATE.

Clerk provided documents to SCC requesting registration of Greatgate grass triangle as a Village Green and SCC provided the following update: The land is not a village green. It is



not registered as such and cannot be registered as a village green. The land is part of the publicly maintainable highway, a status which can only be extinguished by way of a legal order. A licence granted by the County pursuant to s96 of the Highways Act 1980. This licence, which was properly granted by the County as highway authority, permits Croxden Parish Council to carry out the activities on the land which are listed in the licence in accordance with what was agreed with the Area Surveyor at the time (as required by clause 1 of the licence). Council considered the update from SCC and RESOLVED to continue with existing arrangement. Clerk to investigate the anniversary date with the view to having a celebration.

### SPCA MOTION TO NALC - UPDATE AND DISCUSS RESPONSE TO NALC.

SPCA provided Croxden PC Motion to NALC in order that NALC can lobby the Government for a national change to be made to speed limits on rural roads. Our suggestion would be to make a simple change to the national speed limit, reducing it to 40mph for carriageway roads without central line marking. This approach has the following advantages: It could be implemented nationally with a simple administrative change by Government. A single national information campaign could be cost effectively run to communicate the benefits of the change to all road users no changes to signage would be required. Croxden Parish Council would ask SPCA to consider the motion to request NALC to pursue this national change of speed limits with Central Government.
